SIGNIFICANT INCIDENTS

July 2, 2019 - At approximately 0830 hours, Sergeant Guzman and officer Sanchez received a service call at 555 South Broadway regarding a possible act of vandalism. Upon arrival, our officers noticed that the windows from the business were shattered. The merchant then provided and accurate description of the suspect which helped our officers located the person in question right down the street. LAPD was notified and responded shortly after. The evidence and camera footage were provided to LAPD which resulted in the apprehension of this individual along with the support of our officers.

July 5, 2019 - At about 1750 hours, Sergeant Ramos and Officer Ballew received a service call about a fight that was occurring over on the corner of 7th and Spring. Upon arrival, our officers maintained a safe distance and noticed that there was an individual bleeding from his forearm. Sergeant Ramos quickly placed out a call and notified LAPD and LAFD. Both units arrived within minutes and determined that the victim who was bleeding had been stabbed. Our officers then notified LAPD that a couple of subjects ran inside the CVS store. LAPD scouted the area and found the suspect who had stabbed the victim. The suspect was then placed in custody based on witnesses and our officer's testimony.

July 10, 2019 - At 2300 hours, Sergeant Ramirez and Trainee Benson were notified by Sergeant Ramos, who was off duty, that there was a bouncer who pinned down a bleeding patron over at the 400 block of spring street. Our officers responded in under 5 mins and saw the situation occur. In an effort to keep both parties safe, Ramirez engaged and detained the suspect (patron) until PD arrived. LAPD responded and spoke to both parties and additional witnesses. In the end, it was determined that the suspect who Ramirez arrested was indeed the aggressor. The bouncer pressed charges which resulted in the suspect's apprehension.

July 15, 2019 - At approximately 1230 hours, Sergeant Guzman and officer Sanchez were on their routine patrol when they came across an individual who was jumping in and out of traffic on the corner of 6th and Main. Our officers continued to monitor the situation and observed what appeared to be a hit and run. The subject was hit by a car at a low rate of speed. Our officers quickly jotted

down the license plate information and handed it over to the authorities once they arrived. The subject was treated for his minor injuries and transported shortly after for a mental evaluation hold.

July 19, 2019 - At approximately 2145 hours, Sergeant Ramos and officer Ballew responded to a service call regarding a known trainset in our district. Callers stated that the transient had taken a fighting stance and was acting aggressively towards pedestrians. Our officers arrived on the scene within minutes and found LAPD already on scene. Ramos and Ballew assisted with pedestrian traffic while PD conducted their field interviews. It was then determined that the transient was the sole aggressor in which he was arrested shortly after for assault charges.

July 27, 2019 - While on their routine patrol, Sergeant Ramos and Officer Ajaa came across the known transient who is always flipping his phone in the air (6th and Spring). Our officers then decided to monitor the individual's activity from a safe distance just in case. Noticing this action, the transient then decided to confront Sergeant Ramos in an aggressive manner. At some point within the conversation, the transient decided to spit at Ramos's face. Within seconds, Ajaa and Ramos acted quickly and subdued the transient based on his actions. PD was notified in which they responded shortly after. The transient was then released shortly after and was advised not to return again. Our officers then thanked LAPD for their quick response and assistance with the situation.

ACCOMPLISHMENTS

July 25, 2019 - At approximately 0430 hours, Captain Pacheco and Officer Ballew were on their routine patrol when they noticed a small garbage fire on the corner of 8th and Broadway. Officers attempted to put out the fire but had no success. LAFD was notified shortly after in which they responded within 3 minutes. The fire was put out quickly by the professionals using advanced tools/ chemicals. After the small blaze was put out, one of the fire personnel had thanked us for our observation. The firefighter claimed that the fire could have easily spread to the building next door due to the flammable items nearby.



At times we bring out the patrol vehicle and park at hotspot areas to deter crime.




Streetplus engages and assists LAPD in arrests as seen here.


