## **SAFE AND FRIENDLY REPORT | MAY 2019**

### SIGNIFICANT INCIDENTS

May 1, 2019 - At approximately 1650 hours, Sergeant Ballew, Officer Bell, and Officer Ajaa noticed a large group of individuals taking part in a march that crossed into our district at Broadway. Without hesitation, our officers were able to assist the large group of pedestrians through our district by providing traffic control. This resulted in a successful/safe afternoon for our officers and pedestrians.

May 3, 2019 - At about 0715 hours, while on patrol, Sergeant Ramos and Officer Sanchez noticed heavy LAPD presence on the corner of 5th and Broadway. After asking a couple of officers about the situation, LAPD confirmed that a domestic violence suspect had barricaded himself inside his apartment unit. Once officers determined that this was a serious call, Ramos and Sanchez went ahead and provided traffic and crowd control to minimize activity flowing into the street. A couple of minutes later, LAPD was able to take the suspect into custody without any further incident.

May 9, 2019 - At 1020 hours, Sergeant Ramos and Officer Bell received a service call from a local merchant located within the 600th of spring street. The merchant stated that two individuals went into their store and took multiple items. Officers were given a lengthy description of the suspects and proceeded with their patrol. About 30mins later, officers spotted two suspects who matched the same description at another store on 6th and Maple who were also shoplifting. When making contact with the 2nd merchant, they advised officers that they want to press charges. Our officers acted quickly and detained both suspects without incident. Once LAPD arrived, they conducted a field show up in which the first merchant was able to positively ID both suspects. The first merchant also pressed charges. Both suspects were then transported by LAPD for shoplifting.

May 16, 2019 - At approximately 0145 hours, Officer Juarez and Officer Perchlak were on their routine patrol when they came across an individual who was slumped over on the side of the street. Concerned about his well-being, officers decided to conduct a wellness check on the individual. Without getting a positive response, Officers immediately contacted LAFD. While checking the individual's vitals, Officer Juarez noticed that the individual had labor breathing. Dispatchers then advised officer Juarez to conduct chest compressions until paramedics

arrived. In doing so, Officer Juarez was able to stabilize the individual until paramedics arrived 4 mins after. The individual was transported to the local hospital shortly after for unknown causes.


May 23, 2019 - At approximately 0500 hours, Officer Solorio and Officer Lemus were on their routine patrol when they noticed fresh tagging at the HCBID offices. Acting very quickly, Officer Solorio and Lemus went ahead and removed the graffiti using special chemical solutions provided by Street Plus. In doing so, officers were able to remove the graffiting and restore the natural color of the affected area.

May 24, 2019 - While on their routine patrol, Sergeant Ballew and Officer Bell came across an individual who was acting belligerent within the district. While keeping a distant visual on the subject, officers noticed the individual tampering with parked vehicles. Upon closer examination, officers noticed what appeared to be tire slashes on the tampered vehicles. Acting in a fast manner, officers contacted LAPD for support. At this point in time, the suspect redirected his attention towards our officers and took a combative stance. While LAPD was in route to our officer's location, Ballew and Bell went ahead and detained the induvial for their safety. Officers then removed the knife from his possession and waited for LAPD to arrive. LAPD arrived in less than 5 mins and took the suspect into custody for an ADW (assault with a deadly weapon). Our officers quick and brave actions were enough to remove a violent criminal off the streets.

### **ACCOMPLISHMENTS**

May 27, 2019- Lisa Myers has been getting significant results within her first months as our new outreach coordinator. During the month of May, Lisa has made contact with 4 transients who had no source of income and were forced to panhandle in the streets of Los Angeles. After passing out a few resources and informing them of what was available to them, the 4 transients were able to get funding through the SSI office. These 4 transients are now able to purchase basic necessities and have been following up with Lisa regularly for the housing opportunities.


