SIGNIFICANT INCIDENTS

September 02, 2020 - At approximately 0800 hours, Sergeant Guzman and officer Castaneda were on their routine patrol when they noticed heavy LAPD activity at 526 s Main street. LAPD notified BID officers that they were in search of an individual who possibly brandished a firearm. BID officers were also given a description of the individual on told to keep an eye out for the subject. As the morning went on, LAPD concluded that there was no imminent threat and cleared the scene shortly after. No suspects were arrest during this incident and our BID officers resumed their routine patrol.

September 04, 2020 - While on patrol, at approximately 0830 hours, officer Castaneda was completing his rounds in the district when he heard a loud bang. Officer Castaneda quickly notified the other BID officers and made his way over to 4th and spring. Once BID officers arrived, they noticed a metro bus that was parked on the side street and a fire hydrant that was tipped over. The fire hydrant released all of the pressurized water from the inside causing the streets to overflow with water. BID officers conducted traffic control around the damaged hydrant and contacted LAFD. LAFD arrived within minutes and repaired the damaged hydrant. LAFD also determined that the metro bus had accidentally crashed alongside the hydrant causing it to burst.

September 11, 2020 - Sergeant Perchlak and officer Solorio were on their routine patrol when a citizen flagged them down at 5th and Broadway, at approximately 2330 hours. The citizen claimed that there was an individual who was walking northbound on Broadway brandishing what appeared to be a firearm. BID officers located the subject and followed from a safe distance while contacting LAPD. LAPD arrived within minutes and located the subject as well. LAPD made contact with the individual and retrieved two replica firearms from his possession. Both replicas were actually pellet guns. LAPD conducted their investigation and cleared the scene once they concluded their report.

September 17, 2020 - At approximately 1440 hours, Sergeant Ramirez, Sergeant Ramos and officer Ajaa were out on the field when they heard a loud bang. Sergeant Ramirez observed people running from the 5th and spring intersection and carefully made his way over there. Upon arrival at 5th and spring one victim was down from an apparent gunshot wound. LAPD

was already dispatched from a previous caller and arrived on scene within seconds. LAFD also arrived on scene and transported the victim to the nearest hospital. LAPD tapped off the scene and interviewed possible witnesses at the crime scene. A suspect was immediately identified by police using surveillance footage from nearby businesses. Once the scene was cleared a BOLO flyer was put out for the suspect. The suspect was eventually apprehended a couple of day later and the victim has since been released from the hospital.

September 28, 2020 - At around 0210 hours, Sergeant Perchlak and Officer Sweeney were on their routine patrol when they spotted an individual who was acting very suspicious. BID officers followed the individual's movement and observed the subject checking the inside of vehicles. BID officers notified LAPD of the subject's behavior and his current movement. The subject then attempted to break into the business on 215 W 7th street. A secondary LAPD call was placed by Sergeant Perchlak. Responding LAPD officers arrived and spotted the suspect in the act. A small foot chased ensued which resulted in the apprehension of the individual. BID officers were thanked by LAPD and cleared from the scene to resume patrol.

September 30, 2020 - At about 1715 hours, BID officers, Ramos and Ajaa, received a service call regarding a man who had assaulted a minor. BID officers responded to the scene and located the victim as well as the suspect a few feet away. After talking to a couple of witness, BID officers were able to confirm that the suspect had physically hit the victim. BID officers then proceed to talk to the suspect. The suspect then began to aggressively swing his fists at the responding BID officers. A use of force incident occurred and the suspect was apprehended by BID officers. LAPD arrived shortly after the service call and took the suspect in for assault charges on a minor.

ACCOMPLISHMENTS

September 2020 - BID officers received a few reports from citizens regarding firearms in the month of September. BID officers made these tips available to LAPD and detectives. LAPD officers worked on these tips and found all firearms to be replicas or false reports. With the exception of one firearm related incident (09-17-20), all reports were attended to and heavily investigated by LAPD.




Officer Carmona remains vigilant while patrolling a busy street.








Officer Castaneda is seen here passing out food items from the mission.

Officer Marquez is seen here conducting his daily merchant contact.




Officers work with neighboring agencies such as DOT who can address parking enforcement issues.
