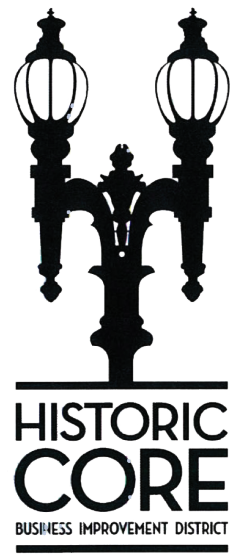


Street Report

SAFE AND FRIENDLY | DECEMBER 2021



The following data and information is provided to the Historic Core BID for tracking purposes. The information contained in this report is for activities reported in December, 2021. The data and information is obtained from Ambassadors conducting patrols and entered in Statview.

SIGNIFICANT INCIDENTS

December 1st - At approximately 1246 hours, while on patrol, BID officer Smith spotted an individual on the ground by 527 S Broadway. BID officer Smith proceeded to make contact to make sure the individual was okay. While making contact, Smith noticed that the individual had difficulty breathing. Smith immediately contacted LAFD for assistance. Chest compressions were administered while paramedics were in route to the location. Upon arrival, paramedics took over the scene and advised Smith that the individual was possibly overdosing. Narcan was administered and the individual regained consciousness. Soon after, the individual was transported by LAFD for further evaluation. Paramedics advised Smith that the subject was in stable condition.

December 3rd - While making his routine rounds on 6th street, BID officer Garcia spotted 2 transients sitting on a couch by the Joes parking lot on 6th and Main. BID officer Garcia made contact with the 2 transients and was able to relocate them to a different area. Garcia placed a priority phone call to our maintenance team for the couch. Garcia then stood by until the maintenance team arrived and successfully removed the couch. With this approach, BID officers are able to identify potential encampments and address them immediately.

December 6th - At approximately 0749 hours, BID officers received a service call regarding a possible encampment in front of the Cecil hotel. BID officers Pirir and Ramirez responded to the location. As soon as BID officers arrived, they were able to identify the items used to build the encampment. BID officers made sure no one was occupying the items before the maintenance request was made. Chrysalis arrived within minutes and was able to dispose all the bulk items. Within the following hour, the sidewalk was clean and accessible to public.

December 8th - At approximately 0507 hours, BID officers received a phone call from LAPD regarding a break in at 460 S Spring Street. BID officers arrived at the location within minutes and were briefed by responding officers about the situation. Apparently, someone smashed the front window and burglarized the business just before 0500 hours. BID officers were then tasked by responding LAPD officers to secure the area once they left the scene. Rowan security took over the

scene at about 0700 hours. The business owner was also contacted, and the front door was successfully replaced. BID officers remained on high alert throughout the day.

December 20th - BID officer Novales and Aragon were conducting their routine patrol at approximately 0156 hours when they heard police activity right around the corner. BID officers quickly made their way to 6th and Broadway and spotted what appeared to be a vehicle pursuit. The fleeing vehicle came to a completed stop at the intersection. BID officers maintained a safe distance from the scene and documented their findings. LAPD cleared BID officers from the area due to the high risk stop they were conducting. Ultimately, the driver was taken into custody without further incident.

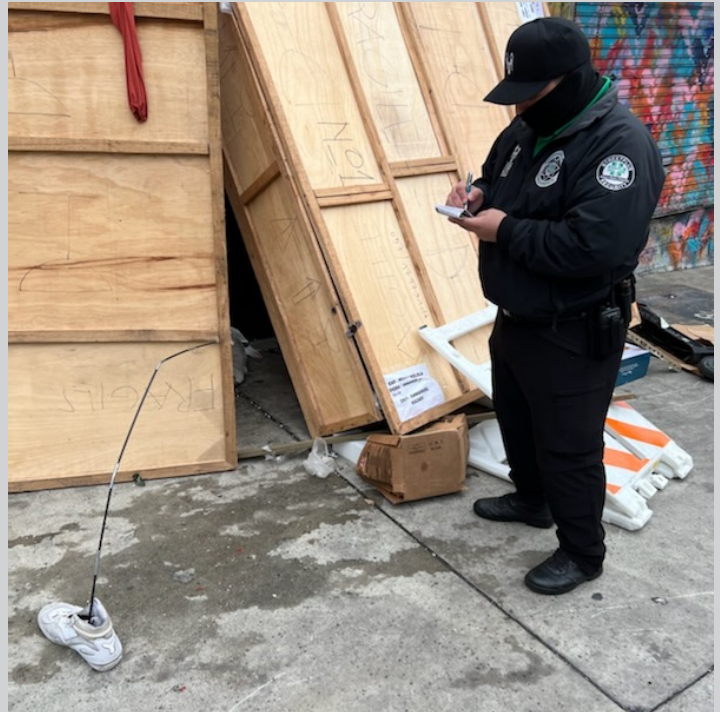
December 21st - BID officers received a notification on the citizen app at around 2038 hours regarding a possible stabbing in the area of 5th and Main Street. BID officers responded to scene with caution and found LAPD securing the area with yellow tape. Through eyewitness testimony, BID officers learned that the suspect ran into the Rosslyn in an effort to elude police. BID officers assisted with pedestrian traffic until they were cleared by LAPD officers. Within a few hours, the scene was cleared, and BID officers made contact with the front desk of the Rosslyn. BID officers were advised that the suspect surrendered peacefully.

ACCOMPLISHMENTS

December 18th, 2021 - The Historic Core BID along with Fashion District and CD14 collaborated together in creating the winter wonderland event. It was a successful outcome as it had a huge turnout. We had visitors from out of town as well as residents from the neighborhood. The Historic Core contributed to the event by providing an information booth as well as foot beat officers. There were no incidents to report that day.



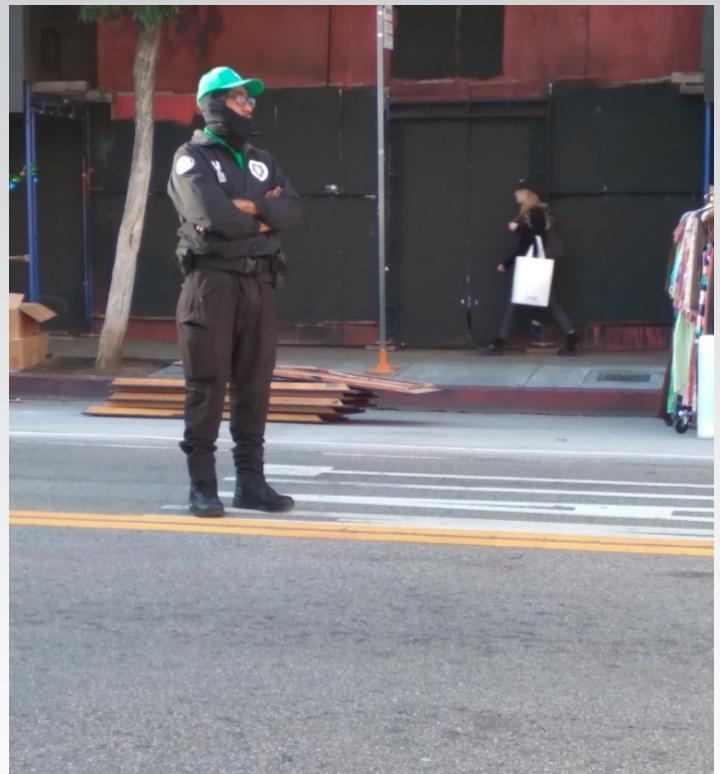
BID officers communicate with various city agencies regularly..



BID officer Carmona is seen here documenting an illegal dumping incident.



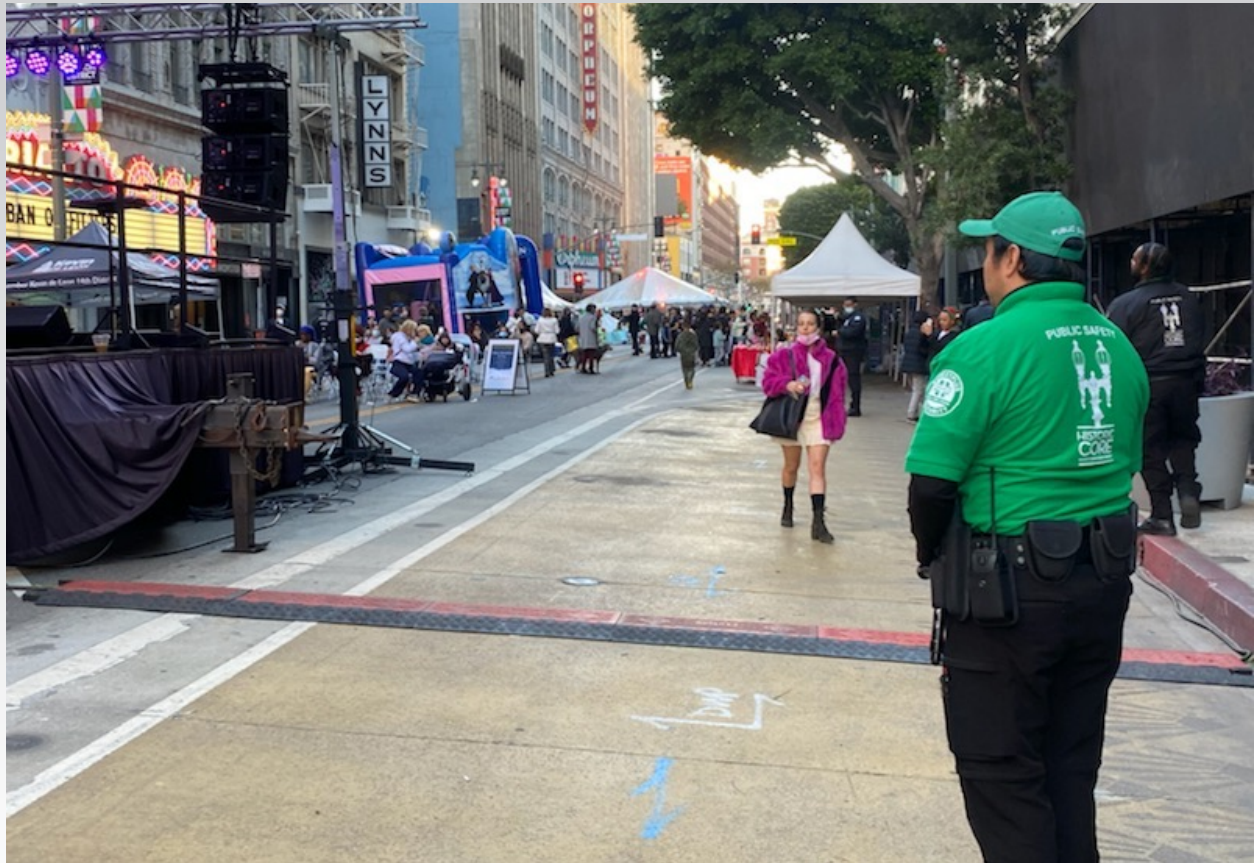
BID officers routinely pick up fallen scooters. You can also call it in if you see it in your area.



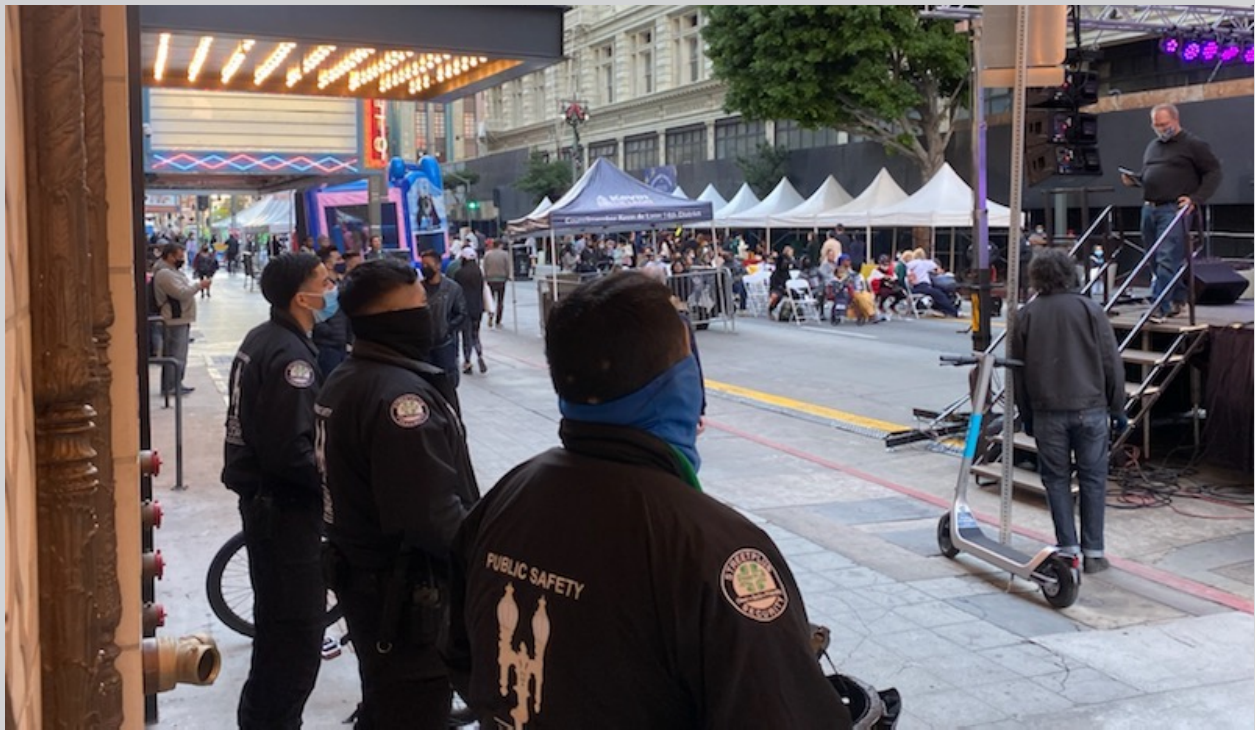
BID officer Ajaa maintains watch during his assigned duty.
