The following data and information is provided to the Historic Core BID for tracking purposes. The information contained in this report is for activities reported in March 2022. The data and information is obtained from Ambassadors conducting patrols and entered in Statview.



HISTORIC CORE BID

SIGNIFICANT INCIDENTS

March 4 - at approximately 1245 hours BID officer Garcia was on patrol when he received a radio call from the clean team, regarding a woman who was not fully clothed. The incident was reported on Los Angeles and 5th street. Upon arrival Garcia was able to locate the woman in question and attempted to make contact. At this point the women became verbally hostile towards Garcia and a secondary call was placed to LAPD. LAPD arrived within minutes and attempted to make contact with the woman. Unfortunately, the woman was being hostile towards the responding officers as well. A small struggle ensued but responding officers were able to detain the woman. They immediately placed a robe on her and took her into custody. Luckily, no one was hurt in regard to this incident.

March 8 - At approximately 1027 hours BID officer Carmona received a call at 7th and Broadway regarding an individual who was being irate with the public. BID officer Carmona went to the scene and requested assistance prior to his arrival. Captain Pacheco was nearby and responded to the radio call for assistance. Upon arrival Pacheco was able to locate the irate individual but was unable to deescalate the situation due to the individual's drug/mental state. BID officers were able to get the individual off the street and onto the sidewalk before LAPD arrived. While LAPD was arriving on scene, the individual jumped in front of an unmarked police cruiser and stood there for 2 minutes. Responding LAPD officers located the subject and proceeded to detain him. LAPD requested for back up due to the individual becoming hostile and aggressive. Multiple officers responded to the scene and quickly regained control of the situation. Once the individual was placed into custody, LAPD officers advised BID officers that the individual was being placed on a 51/50 hold due to his mental state.

March 12th - While on his routine patrol, BID officer Garcia received a service call regarding an individual who did not want to leave the business on 6th and Spring. BID officer Garcia was able to respond to the call quickly and located the subject inside of the business. During the initial contact, the subject was cooperative and exited the business. While the subject was outside, Garcia noticed that the individual was becoming aggressive towards the public. At one point, the subject was going in and out of vehicle traffic. Garcia radioed nearby BID officers for assistance. As soon as the individual saw multiple BID officers arrive at the location, he decided to stay on the sidewalk. BID officers monitored the individual's activity from a safe distance until he ultimately left within a few minutes.

March 15th - At approximately 0030 hours BID officers received a citizen notification regarding a burglary that occurred on 6th and Spring. As BID officers made their way to the scene, they noticed that LAPD had already arrived with multiple units. BID officers noticed that the glass door of the business had been broken into. Within a few minutes, BID officers were able to confirm through LAPD that one suspect was in custody in question to the burglary that had just occurred. BID officers were able to gather enough

information for the report and were cleared from the scene right after.

March 17th - At around 0220 hours BID officer Novales was on patrol on the corner of 6th and Main when he was flagged down by a group of people. The group had advised Novales that an individual who was seen laying down on the ground was intoxicated. BID officer Novales contacted LAFD for assistance and also noticed the individual had a small laceration to his head. BID officer Novales provided preliminary aid before paramedics arrived on scene. Once LAFD showed up, they were able to stabilize the individual and loaded him up onto a gurney in a conscious state. It appeared that the individual was heavily intoxicated causing him to fall and hit his head. Before LAFD cleared BID officers from the scene, they advised him that the injuries were non-life threatening.

March 20th - At about 1050 hours BID officer Pirir was at the farmers market security booth when he noticed a pedestrian get physically hit by the corner of 5th and Spring. The male subject appeared to be under the influences of an unknown substance. BID officer Pirir requested assistance and responding BID officers arrived on scene and attempted to deescalate the situation. The individual became irate and decided to throw a nearby chair at one of the BID officers. LAPD was contacted immediately and arrived shortly after. LAPD located the individual and took him into custody without further incident. They arrested the individual on battery charges and transported him to the nearest jail facility. BID officer Pirir was offered medical treatment but declined due to non-serious injuries.


March 26th - While on patrol, at approximately 0505 hours BID officer Novales was on his routine patrol when he noticed a small trash fire on the corner of Olympic and Hill. BID officer Novales sprang into action and retrieved the fire extinguisher from the patrol vehicle. Novales immediately extinguished the trash fire within a matter of seconds. While the fire was taken care of, BID officer Novales stood by the area to make sure no other individual came back and attempted to start up the fire again.

SIGNIFICANT ACCOMPLISHMENTS

At approximately 2120 hours while on patrol BID officers Ballesteros and Garcia were flagged down by a pedestrian on Winston and Los Angeles regarding an unconscious individual. When BID officers made contact, they noticed the individual was having trouble breathing. BID officers immediately placed a radio call for assistance and also contacted LAFD. LAFD advised BID officers to conduct chest compressions on the individual. As chest compressions were administered LAFD arrived on scene and took over the situation. In addition, the individual was given Narcan in order to stabilize his condition. Once the individual was stabilized LAFD told BID officers that he was going through an overdose. The chest compressions that were administered in the beginning was a critical moment as it kept the individual breathing until paramedics arrived. BID officers were thanked and released from the scene shortly after.




