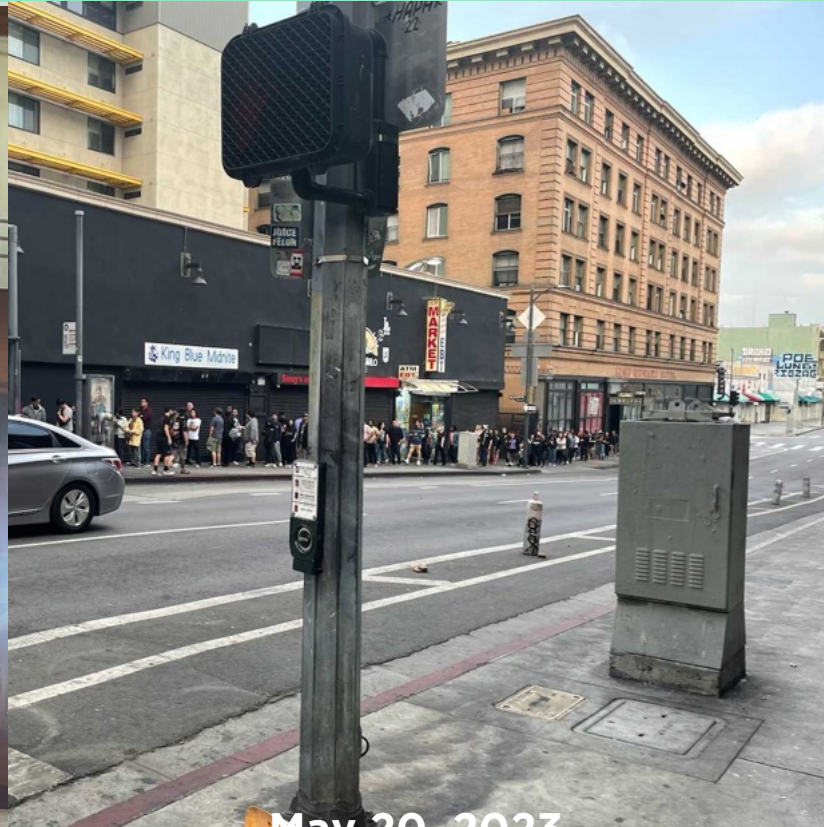

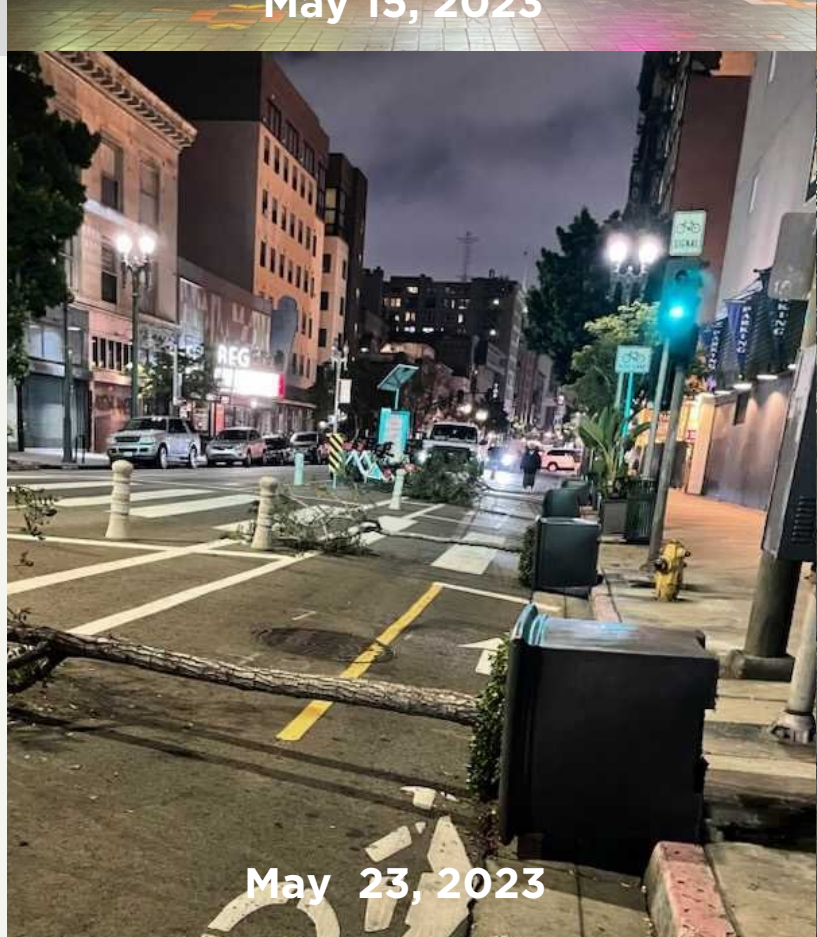

# Safety Report



**May 2023**

**On May 2, 2023,**

around 1720 hours, a Historic Core BID officer was dispatched in response to a call about a transient individual lying near the intersection of 6th and Spring. Upon reaching the scene, the officer encountered a cooperative suspect. Following the officer's instructions, the transient willingly moved away from the area. The situation was resolved peacefully and without any complications or subsequent incidents.

**On May 4, 2023,**

around 1545 hours, a Historic Core BID officer conducted a routine patrol and observed a group of individuals loitering in front of 548 S. Spring St. The officer approached the subjects and courteously asked them to move away from the area. The loitering individuals cooperated without any resistance, calmly collecting their belongings and paraphernalia as instructed by the officer. They left the location peacefully and without incident.

**On May 10, 2023,**

around 0100 hours, a Historic Core BID officer was on patrol when they encountered a hit and run incident. The two individuals involved in the collision had halted their vehicles. The officer promptly intervened, diffusing the situation and assisting in the exchange of information between both parties. Consequently, the matter was effectively resolved.

**On May 13, 2023,**

at approximately 0600 hours, a Historic Core BID officer swiftly responded to an urgent call concerning an unresponsive individual. Upon reaching the scene, the officer promptly guided pedestrians to call 911 for assistance. The unresponsive state of an African American female was discovered, leading to the immediate administration of CPR. Sustained chest compressions were maintained for approximately 10-15 minutes, culminating in her successful resuscitation. Subsequently, the Los Angeles Fire Department (LAFD) arrived to provide further medical support.

**May 2023**

**On May 15, 2023,**

around 0615 hours, a Historic Core BID officer observed that the roll-up gate of a business situated at 7th and Broadway was ajar. Immediate contact was established, and it was ascertained that the gate had been unintentionally left open. Subsequent investigation revealed that everything was in its rightful place, with no indications of suspicious activities or potential threats. As a result, the situation was determined to be resolved without any concerns.

**On May 20, 2024,**

a substantial gathering of individuals was observed queuing along 5th & Main St, with the line extending towards Los Angeles St. The queue had formed in anticipation of an event scheduled at 448 S Main St.

**On May 23, 2023,**

around 0230 hours, during a routine patrol, a Historic Core BID officer observed several trees knocked over in the bike lane. Collaboratively, Historic Core BID officers mobilized to upright the fallen trees and return them to their original positions on the sidewalk.

**On May 26, 2023,**

around 2030 hours, during a routine patrol, a Historic Core BID officer observed that the fences at 610 S. Main St had been knocked over. The BID officers promptly rectified the situation by picking up the fallen fences and securing them using zip ties.
