









SAFETY REPORT SEPTEMBER 2023

SEPT 1ST	On September 1, 2023, at approximately 1100 hours, a Historic Core BID officer, while on patrol, noticed a group of individuals seated in the middle of the sidewalk, causing an obstruction. Upon closer inspection, it became evident that these individuals were involved in drug-related activities. The officer promptly instructed them to vacate the area. Patiently, the BID officer waited until all of the individuals gathered their belongings and departed from the vicinity.
SEPT 5TH	On September 5, 2023, at approximately 0800 hours, a Historic Core BID officer conducting patrol observed a man lying on the ground. Approaching the scene, the officers inquired with the individuals standing nearby. One bystander mentioned that the man had fallen and struck his head. Regrettably, the man showed no signs of responsiveness. Emergency Medical Technicians (EMTs) were immediately contacted and swiftly arrived at the location. They subsequently transported the man to the hospital for further care.
SEPT 6TH	On September 6, 2023, a Historic Core BID officer on patrol noticed a familiar panhandler approaching individuals and requesting money. The officer politely requested her to move to a different location. The woman disregarded the officer's instructions and persisted in asking people for money. The BID officer reiterated the need for her to relocate. After a period of ten minutes, during which the officer maintained a presence, the woman eventually decided to move to a different spot
SEPT 8TH	On September 8, 2023, at approximately 1:30 PM, a Historic Core BID officer was alerted to the presence of multiple individuals congregating on the side of the building at 510 S. Spring. With caution, the BID officers approached the group and requested that they move to a different location. The officers then remained on standby while each individual gathered their belongings and made their way to the new area.

SEPT 13TH	On September 13, 2023, at approximately 6:55 pm, a Historic Core BID officer conducting patrol observed an individual who appeared to be unconscious at the corner of 5th and Spring. Upon conducting a wellness check, the subject showed signs of responsiveness. I politely asked if she could move to a different location. The individual complied and proceeded north on Spring.
SEPT 15TH	On September 15, 2023, at approximately 8:30 AM, a Historic Core BID officer was signaled for assistance. The officer received information about a Hispanic male who was observed walking down the street, damaging properties with a metal pipe and rod. The BID officer promptly approached the individual, who was in the act of attempting to break windows as he walked. The man displayed verbal aggression and combative behavior. Despite multiple warnings to relinquish the metal rod and pipe, he eventually complied and placed them on the ground along with his backpack. Subsequently, the man relocated outside of the district. The LAPD was contacted and informed of the direction in which he was headed.
SEPT 20TH	On September 20, 2023, a service call was received for the 500 block of S Los Angeles. The caller reported an adult male sleeping outside of their business. Upon arrival, the BID officer observed that the man had a facial injury. The officer inquired if the man required medical assistance, but he declined. Instead, he got up and proceeded to walk southbound on Los Angeles.
SEPT 25TH	On September 25, 2023, at approximately 4:32 PM, a Historic Core BID officer on patrol witnessed a woman engaging in indecent exposure on 6th Street. Upon approaching her, the officer instructed the woman to cover herself and informed her that she would need to find another location. The woman promptly gathered her belongings and proceeded to relocate.
