







SAFETY REPORT NOVEMBER 2023

On November 1st, 2023, at approximately 2:15 AM, a Historic Core BID safety officer conducting patrol observed a large gathering at the intersection of 7th and Spring. This congregation materialized following the closure of a nearby bar. The large gathering obstructed traffic and engaged in disruptive behavior, including spinning cars in circles within the intersection. The Historic Core safety officer promptly reported the street takeover to the local police. Within minutes, law enforcement arrived on the scene, prompting the group to disperse.

On November 3, 2023, at approximately 2:33 pm, during routine patrol, a safety officer from Historic Core BID encountered three individuals loitering and engaging in drug-related activities outside a business on 6th Street. Upon arrival, the safety officer informed them of the violation and requested that they relocate. Following the officer's instructions, all three individuals gathered their belongings and relocated.

On November 8, 2023, at approximately 5:20 pm, while on patrol, a Historic Core BID safety officer observed two individuals blocking the sidewalk and engaging in drug-related activities in front of a business on S. Los Angeles Street. The safety officer made contact, advising the individuals that they needed to relocate. After a few minutes, the individuals gathered their belongings and relocated.

On November 10, 2023, around 6:30 AM, while conducting a routine patrol along S. Broadway, a Historic Core BID officer noticed an individual obstructing a door, preventing people inside from exiting. The officer initiated contact, but the individual responded with aggression, expressing a desire to engage in a physical altercation. Recognizing the escalating situation, the safety officer called for backup. Upon the arrival of additional support, both officers approached the individual again. Faced with the increased presence, the aggressive individual got up and relocated.



SAFETY REPORT NOVEMBER 2023

On November 15, 2023, at approximately 10:35 am, during routine patrol on S. Broadway, a Historic Core BID officer observed a woman on the corner of 7th and Broadway standing in the middle of the street with her pants down. The BID officer was able to guide her to the sidewalk safely. The BID officer called the Historic outreach person to assist the woman with some pants. However, she refused the clothing and proceeded to walk north on Broadway.

At around midnight on November 18, 2023, at approximately 12:00 am, while conducting a routine patrol heading northbound on S. Los Angeles, a Historic Core BID officer encountered a fallen tree obstructing the thoroughfare. Recognizing the potential hazard, the officer promptly called the LAPD for assistance. During the wait for the police and fire department to arrive, the BID officer took proactive measures by placing yellow "Caution" tape around the fallen tree, enhancing its visibility for approaching drivers.

On November 18, 2023, around 8:45 am, a Historic Core BID officer responded to a service call from our clean team reporting two individuals engaging in verbal aggression and refusing to vacate the premises. Two safety officers promptly arrived on the scene. Upon their arrival, the individuals were informed of the violations and urged to relocate.

On November 23, 2023, at approximately 7:50 pm, a Historic Core BID officer observed an individual on S Main St soliciting money from people waiting in line to enter the theater. The individual displayed signs of frustration when met with refusals. The BID officer approached the individual and requested relocation. Subsequently, the individual moved south on Main St.






