







SAFETY REPORT JULY 2024

On Monday July 1st at approximately 07:43 hours on duty Sergeant Atzin Morales received a service call from 214 W 7th St, regarding a subject B/M wearing a blue hoodie over black jeans that was loitering in the area. Sergeant Morales immediately responded to the call and observed that the subject was blocking the emergency exit for the tenants of the building. Sergeant Morales further observed that the subject was under the influence of a controlled substance, the subject was impairing to a degree to safely perform. Sergeant Morales proceeded to communicate with the subject and instruct him to relocate from the area. The subject became unfriendly and aggressive but gathered his personal belongings from the area and relocated Southbound on Spring Street.

On Tuesday, July 2nd, at approximately 01:26 hours on duty, bike patrol officer Osvaldo Chavez responded to a call regarding a traffic collision that occurred on the corner of 6th and Broadway. Upon arrival, Officer Chavez observed that one of the vehicles (Gray Honda) involved in the collision had smashed into a business, causing property damage to the main entrance roll-up gate. The other vehicle had departed from the scene driving westbound on 6ths street. Officer Chavez immediately gave the driver medical assistance and notified the LAPD along with paramedics to respond to the scene for further help. The driver was conscious and alert but requested medical assistance due to the hard impact. The paramedic arrived at the scene and performed first aid to the victim. The victim was transported to a nearby hospital. The LAPD conducted a further investigation and was able to locate the second vehicle that was involved in the traffic collision.

On July 2, 2024, at approximately 14:50 hours on duty, bike patrol officer Jhairo Valentin responded to a service call at the corner of 6th and Main streets regarding multiple individuals loitering and smoking narcotics in the area. Upon arrival, Officer Valentin instructed the individuals to gather their personal belongings and to relocate from the area. The individuals had impulsive and risky behavior and were becoming physically violent towards others. Officer Valentin remained calm and allowed them to express their feelings. The individuals began to act in accordance with the request and gather their personal belongings. Officer Valentin stood by and ensured that all the individuals relocated away from the district.

On July 6th at approximately 15:30 hours on duty, Sergeant Garcia received a call from 731 S. Broadway regarding an assault incident that transpired. Upon arrival, Sergeant Garcia made contact with the owner of the business who stated that he confronted a B/M that was attempting to take some of the exterior furniture from the business. The suspect then proceeded to assault him with a knife and departed from the area. Sergeant Garcia patrolled the area and was successful in locating the suspect. The suspect then proceeded to depart from the district and enter the 7th Street Metro station. Sergeant Garcia waited for the LAPD to arrive at the scene and gave a complete description of the suspect. The LAPD then proceeded to conduct a police report and monitor the area.


On July 9th at approximately 10:30 hours, Sergeant Ajaa received a call from DCBID regarding a H/M suspect that thrust a knife into someone and was currently on the corner of 7th and Spring Street. Sergeant Ajaa responded to the call and immediately observed the individual walking Eastbound on 7th Street. Sergeant Ajaa continued to monitor the suspect from a distance and maintain constant communication with the DCBID officers and LAPD dispatch. At approximately 10:35 hours, LAPD units arrived at the site and apprehended the suspect and took him into custody for battery and assault. Sergeant Ajaa then proceeded to notify the DCBID officers that the suspect was taken into custody

On July 11th, approximately 01:27 hours on duty, Sargent Morales received a service call regarding a trash can on fire at the Northeast corner of 6th/ Maple. Morales responded quickly and extinguished the fire with a water pump device located in the Historic Core patrol vehicle. At approximately 01:35 hours LAFD arrived on scene to further investigate the arson incident that transpired. Sergeant Morales then continued to monitor and patrol around the area to prevent any further incidents. LAFD departed from the scene and the area was secured


On July 11th at approximately 03:22 hours, Sargent Morales and Public Safety Officer Torres were patrolling eastbound on 6th street between Main / Spring when both officers observed a massive fire in the alley behind 541 S Spring. The fire ignited due to a heavy trash load in the rear alley. Both officers quickly conducted pedestrian traffic control and proceeded to contact emergency services (LAFD) for further assistance. Sergeant Morales then proceeded to contact the on-duty security officer from the residential business who immediately notified the property management team of the arson incident that transpired. LAFD arrived within minutes and proceeded to extinguish the fire. Sergeant Morales assisted LAFD as needed until the fire was completely extinguished.

On July 24th, at approximately 15:00 hours on duty on bike patrol officer Valentin observed that various fence panels in 6th and main were taken down and on the floor. Officer Valentin immediately notified all units via security radio. Captain Fregoso along with on-duty maintenance supervisor Eduardo, responded to the area to further assist. Captain Fregoso instructed the BID officers to respond to the area to assist with installing the fence panels back in place and securing them. The clean team also responded to further assist with the installation of the panels and the area was resecure
