# SAFETY REPORT

## JUNE 2024

On June 2 at approximately 15:27 hours, S/O Valentin responded to a service call at 719. S Broadway regarding 4 individuals loitering outside the business. Upon arrival, S/O Valentin observed that the 4 individuals were drinking and smoking in front of the business. The 4 individuals were intoxicated and had a hard time balancing. S/O Valentin immediately made contact with the 4 subjects and instructed them to dispose of their alcoholic beverages and depart from the area. The 4 subjects complied by disposing of their drinks, gathering their personal belongings and leaving the area.

On June 2 at approximately 15:12 hours on duty, bike patrol officer Jhairo Valentin, while patrolling the intersection of 5th and Spring Street, observed a male Hispanic at the Farmer's Market acting incoherent and attempting to grab items from the vendors. S/O Valentin immediately made contact with the individual to try to listen to what he was saying respectfully. S/O Valentin provided emotional support and listened as the subject acted in accordance with the request and proceeded to depart from the district.

On June 3rd at approximately 15:46 hours, on bike patrol, Sergeant Morales received a call from 557. S Spring regarding a male subject that was disposing of trash in the front of the building. Upon arrival, Sergeant Morales made contact with the subject and observed that the subject was under the influence of a controlled substance. Sergeant Morales remained calm and tried to gently lead the intoxicated person to a safe environment away from the building. Sergeant. The subject complied with gathering her personal belongings and departed from the area. Sergeant Morales placed a service request for the Historic BID cleaning crew to clean and power wash the area.

On June 4th at approximately 20:25 hours, while on patrol, S/O, Valentin observed LAFD activity at 526 S. Main Street. Upon arrival, S/O Valentin made contact with the security in the front lobby, who stated that they had a medical emergency, and that a paramedic was attending to the victim. According to the building security, the victim was having difficulties breathing. After further analysis, the victim refused to be transported to the hospital and the paramedic departed from the area.

On June 5th, at approximately 12:15 hours on duty, on bike patrol, Sergeant Ajaa, while on patrol, observed heavy LAPD activity on the corner of Broadway and 7th Street. The LAPD informed Sergeant Ajaa that they were responding to a stolen vehicle incident that happened and requested assistance with securing the area. Sergeant Ajaa immediately assisted with securing the area and directing pedestrian traffic. The LAPD was successful with apprehending the suspect driving the stolen vehicle and instructed Sergeant Morales to resume normal pedestrian traffic. The LAPD departed from the area and the area remained secure.

On June 5th, at approximately 08:30 hours on duty, Sergeant Ajaa, while conducting a wellness check at 753 S. Broadway, observed a male subject lying on the floor that appeared to need medical assistance. Sergeant Ajaa immediately attempted to communicate with the subject, who appeared to have a medical disorder. Sergeant Ajaa further observed that the subject was slowed breathing and immediately proceeded to call 9-1-1 (paramedics) for further assistance. S/O Valentin remained with the subject and had the 9-1-1 operator on speakerphone until the paramedics arrived on the scene. The paramedic immediately administered first aid and transported the subject to the nearby hospital for further analysis.

On June 23rd at approximately 05:25 hours, S/O Valentin arrived to a service call regarding a vehicle collision on the corner of 4th and Main Street. Upon arrival, the two individuals involved in the accident were very hostile and confrontational. S/O Valentin immediately dissolved their anger towards each other in a relatively efficient and respectful manner. S/O Valentine requested paramedics and LAPD to respond to the scene to further assist both parties. S/O Valentin then proceeded to contact the property management team from 400 S Main Street to obtain CCTV footage of the traffic collision incident that transpired. The LAPD requested the footage and both parties exchanged insurance information and departed from the area, declined medical assistance.

On June 23rd, at approximately 09:35 hours on duty, bike patrol officer Montoya, while patrolling 5th & Broadway Street observed a male subject lying on the floor that appeared to need medical assistance. S/O Montoya immediately attempted to communicate with the subject, who appeared to have an accidental overdose alert. The subject was unable to speak and was breathing slowly. S/O Montoya immediately proceeded to call 9-1-1 paramedics for further assistance. S/O Montoya remained with the subject and had the 9-1-1 operator on speakerphone until the paramedics arrived on the scene. The paramedic immediately administered first aid and transported the subject to the nearby hospital for further analysis.
