



SAFETY REPORT AUGUST 2024

On August 1st, at approximately 08:00 hours on duty, Sergeant Garcia was patrolling the area of 4th and Los Angeles when he encountered a black male completely revealed and attempting to block vehicle traffic. Sergeant Gracia immediately made contact with the subject and instructed him to remain on the sidewalk while he asked for a bike patrol officer to respond to his location with some clothes. On duty, bike patrol officer Montoya acknowledged the call and gathered some clothes from the station, responding to Sergeant Garcia's location. The subject complied by dressing himself and proceeded to depart from the area.

On August 2nd at approximately 1900 hours, Sergeant Novales received a call via security radio from the Clean Team member regarding a Hot Dog vendor that was refusing to comply and relocate his belongings from the area for him to conduct his power wash. Sergeant Novales immediately responded to the location and, upon his arrival, made contact with the vendor, who stated that he just needed more time to relocate. Sergeant Novales proceeded to work with both sides in order to bring about an agreement. Sergeant Novales was successful with settling the dispute and the vendor relocated, allowing the Clean Team member to complete power washing the sidewalk.

On August 3rd at approximately 1700 hours on duty Sergeant Garcia observed a suspicious vehicle parked in front of 225 W 6th street. The subject inside the vehicle Hispanic Male appears to be under the influence of a control substance. The driver of the vehicle later became unconscious inside the vehicle. He also had multiple canisters of Nitrous Oxide tanks inside the vehicle. Sergeant Garcia immediately placed a call to LAPD and requested a unit to be dispatch to the location to further investigate the suspicious vehicle. Upon arrival LAPD made contact with the driver and were successful on waking the driver and proceeded to arrest him for driving under the influence. The vehicle was towed away by LAPD and the driver was arrested for driving under the influence.

On August 4th, at approximately 1200 hours on duty, bike patrol officer Rayford received a call regarding a Clean Team Member that was requesting paramedics due to a power washing incident that occurred at the corner of 4th and Spring Street. Upon arrival, officer Rayford observed that a clean team member was bleeding from his right foot and was attempting to remove his working boots, attempting to address the issue. Officer Rayford immediately called 911 and requested paramedics to the location to further assist. After further investigation, officer Rayford determined that the clean team employee was power washing the sidewalk and had accidentally utilized the power wash equipment to power wash his foot, causing severe damage and bleeding to his right foot. At approximately 1205 hours, LAFD arrived at scene and administrated first aid to the victim. The Clean Team Member was transported to the nearby hospital for further evaluation.

On August 9, 2024, at approximately 14:50 hours on duty, bike patrol Sergeant Garcia responded to a service call at the corner of 6th and Main streets regarding a Black Male loitering and smoking narcotics in the area. Upon arrival, Sergeant Garcia instructed the individuals with a loud tone of voice to gather their personal belongings and to relocate from the area. The subject was becoming physically violent and appeared to be under the influence of a controlled substance. Sergeant Garcia then proceeded to maintain open communication with the subject. The subject began to act in accordance with the request and gather his personal belongings. Sergeant Garcia stood by and ensured that all the individuals relocated away from the district.

On August 10, 2024, at approximately on duty, Sergeant Garcia received a call from a Clean Team Member at the location of Broadway and 6th Street regarding a black Male subject that was assaulting him and attempting to physically fight him. Upon arrival, Sergeant Garcia made contact with the subject, who stated that the Clean Team Member wanted to clean the area that he was currently occupying. Sergeant Garcia offered the individual a bottle of water and attempted to make something clear or understandable for the subject to be compliant. The subject began to act in accordance with the request and began to gather his personal belongings and departed from the area.

On August 20th at approximately 20:00 hours on duty bike patrol officer Valentin on the corner of 5th and Main observed a male subject laying on the floor. Officer Valentin immediately attempted to make contact with the subject but observed that he was not responding to his commands. The subject was unresponsive, unable to talk, and his body was very limp. His face was also very pale. Officer Valentin immediately placed a 911 call and requested paramedics to respond to his location to further assist. Officer Valentin began to administrate first aid (Chest Compression) and continued to check the airway of the victim. Upon arrival of the paramedics, they continue with the first aid and utilize the defibrillator to further assist the victim. The victim became responsive and was transported to the nears hospital.

On August 26, at approximately 0600 hours on duty sergeant Ajaa while patrolling the area observed property damage done to the business of (Footlocker) at 749 S Broadway. The from entrance glass door to the business was completely shattered and there was major glass on the floor. Officer Ajaa immediately secured the area and called 911 for LAPD to respond to further assist. While waiting for LAPD arrival, Sergeant Ajaa observed a Black Male exiting from the business carrying multiple items from the store and attempting to depart from the area. Sergeant Ajaa immediately relayed the information to the LAPD dispatch and requested further assistance from a BID officer. On duty bike patrol officer Montoya immediately arrived on site and assisted with tracking the suspect until LAPD arrival. The suspect was immediately detained by LAPD and arrested for Breaking and entering.


