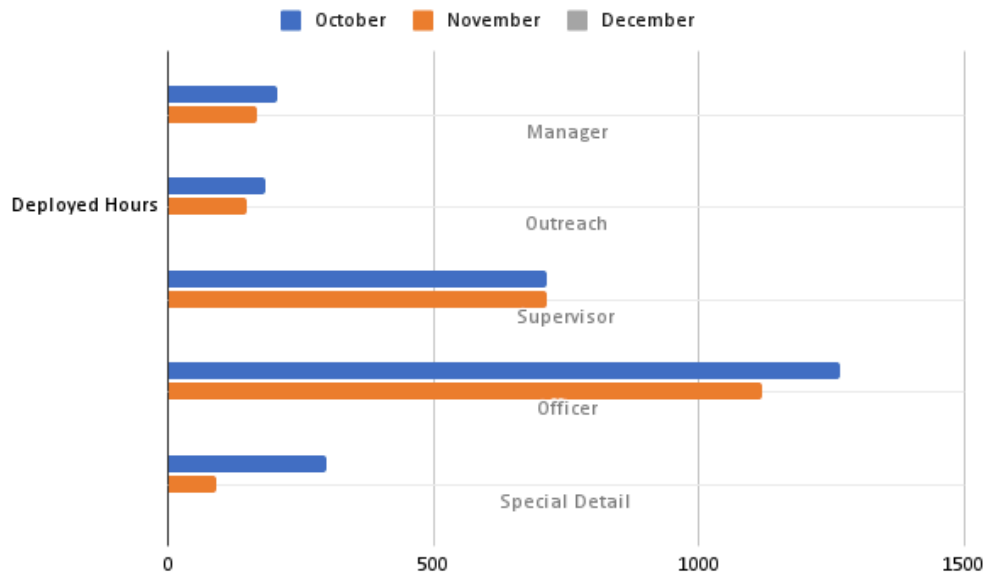

On November 1st at approximately 9am on duty Captain along with Safety Patrol Officers monitor the district for potential Dodgers fans that might attempt to vandalize or conduct street takeovers due to the Dodger parade celebration. An estimated 200,00 people attended the Dodger Championship parade in Downtown Los Angeles. Captain Fregoso along with Safety patrol units maintained constant watch and conducted business checks to ensure the safety of the district. At approximately 4pm most of the Dodger fans had departed from the district and there were no incidents to report.

On November 3, at approximately 1900 hours, on duty, Sergeant Morales received a call regarding property damage that occurred at 205 W 7th Street. Upon arrival, Sergeant Morales made contact with the art gallery owner, who stated that a white male subject was walking eastbound on 7th Street when he threw a large metal object towards the gallery glass window, causing the window to shatter. Sergeant Morales immediately gathered footage of the suspect and notified LAPD of the vandalism incident that transpired. Captain Fregoso conducted a BOLO memo and follow-up with the business owner.

On November 9, at approximately 1300 hours, on duty, Sergeant Garcia was flagged down on the corner of 6th and Main Street regarding a possible OD. Sergeant Garcia immediately began to conduct chest compressions and placed a 911 call requesting paramedics. Upon paramedic arrival, immediately administered Narcan and proceeded to conduct chest compression. The subject began to respond to the paramedic command and became alert. The subject requested to be transported to the hospital for further evaluation.

On November 15th at approximately 1700 hours, on duty bike patrol officer Montoya responded to a vehicle traffic collision on the corner of 5th and Los Angeles. Upon arrival at the location, Officer Montoya observed that a motorcyclist was involved in a collision accident and requested for paramedics. Officer Montoya, along with Officer Urena, secured the area and assisted with vehicle and pedestrian traffic control. The paramedic arrived on site and immediately provided first aid to the victim. LAPD officers responded to the call and further assisted with collecting information about both parties involved in the traffic collision. The victim was transported to the nearest hospital for further evaluation.



On November 20th at approximately 1500 hours on duty Sergeant Garcia, while conducting patrol observed multiple individuals on the South/West corner of 7th and Main Street loitering and conducting narcotics. The individuals were under the influence of a control substance and were being combative towards pedestrians walking in the area. Sergeant Garcia immediately made contact and instructed them to relocate from the area. Sergeant Gacia proceeded to contact LAPD to further assist with relocating the individuals. The subjects became compliant and began to gather their personal belongings.

On November the 21st at approximately 1700 hours on duty Sergeant Ajaa received a call from 541 S Spring regarding a Black Male subject inside the Arcade corridor causing a disturbance. Upon arrival Sergeant Ajaa observed building security was attempting to escort a black male subject from the business. The subject was ignoring the security commands and attempting to gain access into the lobby restroom. Sergeant Ajaa immediately began to listen to his concerns and remain calm and respectful. The subject then began to be complied and departed from the area and was instructed to utilize public restroom.

On November the 25th Captain Fregoso while patrolling the district encountered an encampment on the North/East side corner of Spring and 5thstreet. Captain Fregoso immediately made contact with the 2 subjects that were occupying the tent. Both subjects became aggressive and appear to have mental health conditions, one subject was carrying a large metal weapon. Captain Fregoso immediately called LAPD for further assistance. LAPD upon arrival determined that the subject carrying the large metal object was not stable and had mental health problems causing a threat. The subject was taken into custody for further evaluations and the other individual departed from the district.

On November 30th at approximately 0600 hours on duty officer Rayford while patrolling the district observed a White Female laying on the floor not responding. Officer Rayford immediately checked the subject?s vital signs, breathing, and pulse and determined to call paramedics for further analysis. Officer Rayford continues to monitor treatment until the paramedic arrives. After further analysis by the paramedics determined that the subject was just intoxicated and needed to rest until she had a state of awareness. Officer Rayford continued to monitor the subject until she regained balance and departed from the district.

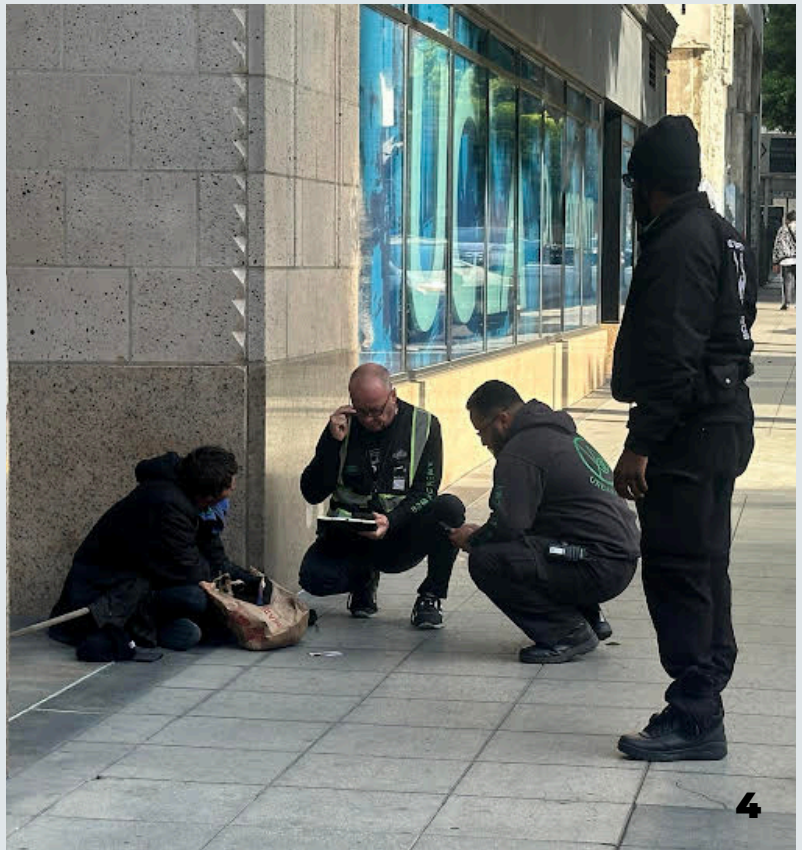
